SONGS Plant Easement History


- 1963: Congress authorized DoN to issue easements to Southern California Edison (SCE) and San Diego Gas & Electric (SDG&E) for use of Camp Pendleton for a nuclear generating station
- 1964: Navy issued 60-year easements
 - Plant Site (84 acres) location of nuclear generating facilities and transmission switchyard
 - Transmission Lines SCE and SDG&E easements for network connection and, previously, SONGS power
 - Access Road access to Plant Site
 - Spur rail track rail transport to Plant Site
- Post 1964 easements
 - SCE transmission easement widened
 - Access road relocation
 - Probable Maximum Flood berm, channel and debris basin

Mesa Lease History/Termination

- 5 Parcels totaling 135.45 acres
- 1982: Mesa property leased to support plant side operations
- 2011: Succeeding lease executed, expires May 2023
- Lease Termination ongoing
 - SCE seeking early termination of parcels 5, 6, & 7 and return of land to DoN
 - Site restoration requires demo, but some facilities to remain
 - Site remediation/clearance underway
 - California Department of Public Health (CDPH) found Mesa adequately surveyed and free of radiological contamination from SONGS operations
 - DoN is reviewing CDPH's assessment
 - Working with state regulators to ensure land meets non-rad decontamination standards prior to termination
- Projected Termination Dates
 - Parcel 5 ~May 18
 - Parcel 7 ~Oct 20
 - Parcel 6 ~Jul 21



Joint Switchyard and SDG&E's Synchronous Condenser



- Switchyard (currently part of plant easement)
- Synchronous Condenser (SDG&E Project)
 - Purpose Voltage regulation for the grid to compensate for SONGS no longer providing generation
 - Construction August 2015 to August 2018
 - Will remain in place after decommissioning

NEPA/CEQA

- CA State Lands Commission is the California Environmental Quality Act (CEQA) lead agency for decommissioning
 - Application filed November 2015
 - Notice Of Preparation of Environmental Impact Report (EIR) July 2016
 - Draft EIR to be issued 1st Qtr 2018*
 - 60 Day Public comment period*
 - Final EIR to be issued 2nd Qtr 2018*
- DoN is NEPA lead agency for proposed real estate actions under the National Environmental Policy Act (NEPA)
 - SCE submits an outgrant questionnaire application post-CEQA 2018*
 - DoN initiates the NEPA decision making process 2018*
 - Draft NEPA Document in 2020*
 - Final NEPA Document issued by 2022*
 - DoN Record of Decision in August 2022*
